K & N Excavating has indicated that they are hoping to get started on the project around May 20, 2013.

Lavadiere Construction has notified the city that they are not going to be able to install the new water lines to the three houses on West Third Street between Cherry Street and Spruce Street. The city has approached K & N Excavating about doing this job when they are in town to complete the East Fourth Street project, and they have stated that they would be willing to do this job as well.

Discussed Spring Clean-Up Days. Mayor Higgins has contacted Jackson Disposal about dates that they have containers available.
