

The Dallas City Council held its regular meeting on May 25, 2016, at 5 p.m. Mayor Kevin Six called the meeting to order with the following commissioners present: Lila Gittings, Esther Newberry, Harold Northup Jr., and Greg Olson.

Others attending the meeting were Gretchen Dodds, Doug Erickson, Chris Classen, Eric Icenogle, and Colton Smith.

A motion was made by Newberry, and 2nd by Olson to accept the minutes of the May 11, 2016, meeting. Gittings, Newberry, Northup, and Olson AYE.

It was reported that some of the boat docks have been put in, and the city is getting an estimate on replacing the docks.

Doug Erickson discussed preliminary plans for sewer renovations. He also discussed the dates that plans should be submitted for low interest loans.

Gretchen Dodds from Ike's Riverfront Tavern reported that the American Legion Fish Fry is being held on May 29, 2016, at Ike's, and she requested permission for Ike's to open at 8 a.m. A motion was made by Northup, and 2nd by Olson to allow Ike's Riverfront Tavern to open at 8 a.m. on May 29, 2016. Chris Classen discussed the boat docks. He also reported that there was a sewer problem that had to be fixed, and it has been taken care of.

Discussed possibly needing to purchase a laptop computer to be used with the recently purchased security cameras. A motion was made by Newberry, and 2nd by Gittings to purchase a refurbished laptop computer if it is needed for the security cameras. Gittings, Newberry, Northup, and Olson AYE.

Discussed repairing the damage to the police pickup that was caused by hitting an owl.

Discussed parking cars on sidewalks. There will be tickets issued if this continues.

Commissioner Northup discussed the problem with finding part-time police officers to work. He feels that the city needs to think about either hiring a second full-time police officer or stop providing police service to the Village of Lomax.

Harold Northup left the meeting at 6:30 p.m.

Discussed purchasing a time clock for the city police. A motion was made by Olson, and 2nd by Gittings to purchase a time clock for \$37.99. Gittings, Newberry, and Olson AYE. Northup ABSENT.

Discussed Christmas decorations/lights. A motion was made by Gittings, and 2nd by Olson to pay Temple Display LTD \$9,200.35 out of the Beautification Fund for Christmas decorations/lights. Gittings, Newberry, and Olson AYE. Northup ABSENT.

A motion was made by Newberry, and 2nd by Gittings to adjourn the meeting. Gittings, Newberry, and Olson AYE. Northup ABSENT.
