

The Dallas City City Council held its regular meeting on June 22, 2016, at 5 p.m. Mayor Kevin Six called the meeting to order with the following commissioners present: Lila Gittings, Esther Newberry, Harold Northup Jr., and Greg Olson.

Others attending the meeting were Doug Erickson, Chris Classen, Trent Woolson, and Eric Icenogle.

A motion was made by Newberry, and 2<sup>nd</sup> by Olson to accept the minutes of the June 8, 2016, meeting. Gittings, Newberry, Northup, and Olson AYE.

Doug Erickson discussed the engineering and design expenses that the city has already paid for the sewer repair project. These expenses can be included in the grant that the city is applying for.

A motion was made by Newberry, and 2<sup>nd</sup> by Olson to pass Ordinance #624 to increase the city's water and sewer rates effective July 1, 2016. The new water rate will be \$17 for the first 1,000 gallons used and \$4.00 per 1,000 gallons used in excess of 1,000 gallons. The sewer rate will be 50% of the water bill plus a \$8.50 sewer charge. Gittings, Newberry, Northup, and Olson AYE.

A motion was made by Gittings, and 2<sup>nd</sup> by Newberry to approve, in tentative form, Ordinance #625, the Ordinance for Appropriations for the May 1, 2016, to April 30, 2017, fiscal year. Gittings, Newberry, Northup, and Olson AYE.

A public hearing on the above mentioned appropriations ordinance will be held on July 13, 2016, at 5 p.m. at the city hall.

Discussed the city police department. The council discussed with Trent Woolson about working 40 hours per week. He is willing to do this. There will be a proposal drawn up for the council to take action on regarding this.

A motion was made by Newberry, and 2<sup>nd</sup> by Gittings to pass Ordinance #626, Ordinance to Adopt Prevailing Wages for 2016. Gittings, Newberry, Northup, and Olson AYE.

Discussed meeting times and place. A motion was made by Northup, and 2<sup>nd</sup> by Olson to continue to have meetings on the 2<sup>nd</sup> and 4<sup>th</sup> Wednesdays of each month at 5 p.m. at the city hall for the 2016-2017 fiscal year. Gittings, Newberry, Northup, and Olson AYE.

Mayor Six read a letter from the Hancock County Economic Development Corporation regarding the city renewing its membership with them. A motion was made by Gittings, and 2<sup>nd</sup> by Olson to renew the city's membership with the Hancock County Economic Development Corporation at the cost of \$1,332.45. Gittings, Newberry, Northup, and Olson AYE.

A motion was made by Northup, and 2<sup>nd</sup> by Newberry to adjourn the meeting. Gittings, Newberry, Northup, and Olson AYE.

The meeting was adjourned at 6:05 p.m.
